## Resolutions

## The Corporation named on this resolution resolves that,

- (1) LCU is designated as a depository for the funds of the Corporation and to provide other financial accommodations indicated in this resolution.
- (2) This resolution shall continue to have effect until express written notice of its rescission or modification has been received and recorded by LCU. Any and all prior resolutions adopted by the Board of Directors of the Corporation and certified to LCU as governing the operation of this Corporation's account(s), are in full force and effect, until LCU receives and acknowledges an express written notice of its revocation, modification or replacement. Any revocation, modification or replacement of a resolution must be accompanied by documentation, satisfactory to LCU, establishing the authority for the changes.
- (3) The signature of an agent on this resolution is conclusive evidence of their authority to act on behalf of the Corporation and to bind the Corporation to this resolution. Any Agent, so long as they act in a representative capacity as an agent of the Corporation, is authorized to make any and all other contracts, agreements, stipulations and orders which they may deem advisable for the effective exercise of the powers indicated on page one, from time to time with LCU, subject to any restrictions on this resolution or otherwise agreed to in writing.
- (4) All transactions, if any, with respect to any deposits or withdrawals by or on behalf of the Corporation LCU prior to the adoption of this resolution are hereby ratified, approved and confirmed.
- (5) The Corporation agrees to the terms and conditions of any account agreement, properly opened by any agent of the Corporation. The Corporation authorizes LCU, at any time, to charge the Corporation for all checks, drafts, or other orders, for the payment of money, that are drawn on LCU, so long as they contain the required number of signatures for this purpose.
